RECOMMENDATIONS

PURPOSE AND GENERAL DIRECTIONS FOR USE: ZMB is a liquid nutrient product that is designed to provide nutrients that may be deficient in the soil or plant. Use 1-2 pints/acre by banding, broadcast, or irrigation application. Although compatible with most pesticides and nutrients, a jar test is recommended. Otherwise, consult your Ultra Gro technical representative. **Shake well before using.**

SUGGESTED APPLICATION

Row Crops, Turf, Tree & Vine Crops:

Foliar: 1-2 pints/acre foliar application. Burning may occur if more than 1 qtr/acre is applied in low volume sprays or with large droplet sizing.

Soil Application: 1-2 qtrs/acre to soil at or near planting on surface or side banded. May also be used with side-dressed plant food.

COMPATIBILITY

ZMB is compatible with most common foliar liquid nutrients and micro-nutrients; however USER ASSUMES FULL RESPONSIBILITY to ensure compatibility when tank mixing with other products.

Do not mix with other components without a compatibility test. An adequate test for compatibility involves mixing in a small container the proper proportions of the product with water and the other ingredients.
