## GENERAL INFORMATION

ILLUMINATE™ ZINC is an organic complexed Zinc fertilizer, for foliar, soil or water run application during primary growth stages. It is intended to be a supplement to a fertility program. Always monitor crop nutrient needs and responses with a soil, leaf tissue and irrigation water analysis program.

## PRECAUTIONS

Agitate prior to use.

## COMPATIBILITY

This product has an acidic pH and is compatible with many commonly applied nutrients and crop protection products. Contact an Ultra Gro representative for a list of compatible mixes. Jar test for compatibility prior to mixing with any pesticides, fertilizers or fertilizer blends. For unfamiliar mixes, an appropriate amount of the final mix should be applied to a small area of the intended crop to ensure plant compatibility prior to the planned application. User assumes full responsibility to ensure product, equipment and plant compatibilities.

## STORAGE AND SHELF LIFE

Store in a sealed container in cool, dry location, at temperatures above freezing. Triple rinse and dispose of containers according to local and federal regulations.

## DIRECTIONS FOR USE

### SOIL APPLICATIONS

Soil apply via mechanical application through direct spray or injection to the soil. Mix with sufficient water for adequate mixing and coverage of target areas. Apply in a uniform manner that avoids undiluted droplets coming into contact with living tissue. It is not recommended in applications where material will come into direct contact with seeds or young roots in its concentrated form. This product should NOT be applied in direct contact with seed and is not recommended for "pop up" applications.

### WATER RUN APPLICATIONS

This material may be water run via drip, flood, and/or furrow. Apply in a uniform manner that avoids undiluted droplets coming into contact with living tissue. When applying this material via a fertigation system, continue to operate the system 30-60 minutes after material has completely injected to flush clean water through the system. Verify compatibility of all system components with acid fertilizers.

### FOLIAR APPLICATIONS

In a clean spray tank, add any dry powders and water and agitate. Add liquid Fertilizers and ILLUMINATE™ ZINC last, continuing agitation. Concentration should not exceed 0.50% (volume to volume) in the finished spray solution. Always use enough water for uniform application and to prevent possible plant tissue damage to the intended crop from concentrated droplets. Contact your Ultra Gro representative for rates when using low-volume and electrostatic sprayers. Apply during the cool part of the day, or when temperatures below 85° F. Do not apply under windy conditions, or other conditions that promote fast drying of leaf surfaces.  
*Maximum Concentration ratio: Mix 1 pint of Illuminate Zinc in no less than 25 gallons of water.*

## SUGGESTED APPLICATION RATES & TIMINGS

### FRUIT TREES & GRAPE VINES & OTHER VINES

**Foliar:** Apply 1-4 pints of ILLUMINATE™ ZINC per acre up to every 7 days during timings of key nutrient demands, in combination with water and any compatible mineral that may be needed. (See *Foliar Application Directions For Use* for proper dilution ratios.)

**Soil/Water Run:** Apply 0.25-2.5 gallons of ILLUMINATE™ ZINC per acre up to every 7 days during timings of key nutrient demands, in combination with water and any compatible mineral that may be needed.

### NUT TREES:

**Foliar:** Apply 1-4 pints of ILLUMINATE™ ZINC per acre during bloom sprays, nut set, summer sprays, and hull split sprays. Repeat in 7 day intervals as needed. (See *Foliar Application Directions For Use* for proper dilution ratios.)

**Soil/Water Run:** Apply 0.25-2.5 gallons of ILLUMINATE™ ZINC per acre up to every 7 days during timings of key nutrient demands, in combination with water and any compatible mineral that may be needed.

### VEGETABLE CROPS, FIELD AND ROW CROPS:

**Foliar:** Apply 1-4 pints of ILLUMINATE™ ZINC per acre up to every 7 days during timings of key nutrient demands, in combination with water and any compatible mineral that may be needed. (See *Foliar Application Directions For Use* for proper dilution ratios.)

**Soil/Water Run:** Apply 0.25-2.5 gallons of Illuminate Zinc per acre up to every 7 days during timings of key nutrient demands, in combination with water and any compatible mineral that may be needed.
